

Türk Telekom Group is Turkey's world-class, integrated telecommunication and technology service provider offering its customers the complete range of mobile, broadband, data, TV and fixed voice services as well as innovative convergence technologies under the unified "Türk Telekom" brand. Turkey is one of the largest telecom markets in EMEA region with 85 mn growing population and increasing number of households.

Overview of Türk Telekom

Türk Telekom was privatised in 2005 and IPO'ed in 2008; underwent a successful transformation resulting in increased efficiency and enlarged service scope.

Unification of mobile, broadband, TV and fixed voice brands under single Türk Telekom brand with a customer oriented and integrated structure.

Strong portfolio of subsidiaries, all well positioned to create value both via supporting core businesses and via third party sales.

Covering 81 cities of Turkey with its 366K km fibre network.

Fibre network covers in excess of 30.2 mn households as of Q4'21 compared to 26.8 mn as of Q4'20, reflecting the increased focus on fibre rollouts.

LTE population coverage expanded to 99% as of Q4'21.

Financial and Operational Highlights

Consolidated revenues increased to TL 34.3 bn, up by 21.2% YoY; the highest annual growth since the IPO. Excluding the IFRIC 12 accounting impact, revenue growth was 19.5% YoY, ahead of the 2021 guidance of 18%.

Consolidated EBITDA grew by 24.0% YoY to TL 16.4 bn, slightly above the 2021 guidance of TL 16.2 bn. EBITDA margin was 47.9%. Excluding the IFRIC 12 impact, EBITDA margin increased by 170 basis points YoY to 50.8%; its annual peak.

Net income reached TL 5.8 bn in 2021, up by 81.3% YoY. The impact of the recent unfavourable FX movements on the bottom line was partly offset by the deferred tax gain recorded in the last guarter.

Total number of Türk Telekom subscribers reached 51.8 mn with 393K net additions in Q4'21. 1.5 mn net subscriber additions in 2021 increased the total base by 2.9% YoY.



Fixed Voice (mn) ----- Fixed Voice ARPU (TL) Naked Broadband (mn)


